### NOTICE FOR ADMISSION TO M. Tech. (2022-2024)

B.I.T, Sindri is a premier technical institute established in 1949 and located in the industrial hub of Sindri and Dhanbad. This is the only institute under the administrative control of Department of **Higher and Technical Education**, Government of Jharkhand providing U.G., PG and research in various disciplines of Engineering. The Institute is fully residential in nature, providing residential facilities (as per availability) to all its students as well as teaching and non-teaching staff. It has a wide 450 acre campus with a sound infrastructure and numerous buildings presenting a spectacle of architectural delight and natural beauty.

Applications are invited for admission to 02 years Full Time M. Tech. program of the Institute in Specialization (Heat power Engineering, Machine Design, Production Technology & Mgt, Power Systems, Control System Engineering, Metallurgical and Materials Engineering, Material Engg. (Nano Technology), Instrumentation & Control (Applied Instrumentation), Structural Engineering, Soil Mechanics & Foundation Engg.) for the session 2022-2024. Up-to-date prevailing reservation policy of Govt. of Jharkhand will be followed. Applicants claiming against reserved seat will have to submit/show online valid caste certificate in proper format in original at the time of counseling, issued by competent authority [Circle officer, Sub Divisional Officer-(Civil) or Dy. Commissioner] of Jharkhand State. The caste certificate issued by any other authority or ant State will not be considered for claim of reservation and his/her claim for reservation will be refused and will be deemed to be as General Category. Caste certificate produced by BC-I and BC-II Applicants will be valid only if he/she does not belong to creamy layer and it should be mentioned in caste certificate. Please note that in such cases validity of the caste certificate is only for 01 year in the case of BC - I & BC - II. The benefit of reservation under Economically Weaker Section (EWS) can be availed upon production of an income and asset certificate issued by a competent authority. However, the caste and EWS certificate must be valid till the time, when the candidate fills the online form. Format will be downloaded from the website (jceceb.jharkhand.gov.in/links/download.aspx).

### **Eligibility Criteria**

Candidates with a valid GATE score with B.E / B. Tech or equivalent degree in respective mentioned discipline with a minimum of 60% marks or equivalent C.G.P.A ( in case of SC/ST the minimum marks of 55% or equivalent C.G.P.A) from recognized University/ Institute approved by AICTE New Delhi are eligible to apply in prescribed format. Candidates possessing above qualifications and having valid GATE score will be entitled for monthly stipend as per the A.I.C.T.E. / Government approved norms as per availability of fund from A.I.C.T.E. (The stipend will be provided to the students subject to approval from AICTE and their attendance must be 75% or above). If seats are not filled up with GATE qualified candidates, Non-GATE candidates may also be considered without monthly stipend.

**Sponsored candidates** are required to apply for M.Tech admission 2022-23 through proper channel. They are required to produce their sponsorship certificate & proper relieving order (As per format given after on the page no.4) at the time of interview/admission, failing which their candidature will not be considered. Also refer Annex I (Letter No. 357 dated 27-03-18 Dept. of Technical Education, Ranchi, Govt.of Jharkhand).

a. For Sponsored candidate priority would be given as per the state government guidelines

b. Private Institution / organization with a condition that they should also submit the IT return or Form 16 of last 03 years (F.Y 2019-20, 2020-21 and 2021-22) for justification of his/her experience

c. No Objection Certificate (NOC) must be submitted on or before 13.09.2022 for sponsored candidates seeking admission in PG programme and must be relieved before 07.10.2022.

NOTE- B.E / B. Tech appearing candidates for 2022 exam may also apply but they have to produce the final result at the time of counseling.

Filled up online application form (Link: <u>https://forms.gle/s1hK2kc4BThKnVa98</u>) must accompany a Non refundable application form fee of Rs. 2500.00 (Two thousand five hundred only) for General ,BCI/BCII category, EWS and outside state candidates of any category and Rs. 2000.00 (Two thousand only) for SC and ST category(Jharkhand state only). - Candidates must possess a Bachelor degree in Engineering / Technology (in relevant branch (a) as per AICTE guidelines) or equivalent, from the institutes recognized by AICTE.
- Gate Score will not be compulsory. However, Candidates need to qualify the Entrance (b) Examination /Interview conducted by BIT Sindri.
- Candidates seeking admission to M.Tech. Programmes of the Institute should have a (c) Minimum 60% or equivalent CGPA (without rounding off) in the qualifying degree for UR/OBC candidates & a Minimum 55% or equivalent CGPA/CPI (without rounding off) in the qualifying degree for SC/ST candidates.
- Preference will be given for filling the sponsored seats in following order:-(d)
  - Faculty of Government Polytechnics of Jharkhand i)
  - Faculty of Private Polytechnics of Jharkhand ii)
  - Employee of State Government / PSU Organizations iii)
  - Other candidates iv)
- Candidates must have a minimum experience of three years, as on 1<sup>st</sup> June of the concerned (e) year, in serving an AICTE approved State Government/Private Technical Institution of Jharkhand or other Department / Organization of Jharkhand.
- A candidate selected for admission under Sponsorship will have to execute a bond to serve (f) his/her parent organization/ institution for a minimum period of two years after the completion of the M.Tech. programme.
