**Submission of Online Application Form for Preparation of State
Merit List on the basis of JEE(Main)-2026 Result**

PRESS COMMUNIQUE

Online Application Forms are invited from candidates having rank in JEE (Main) – 2026 for preparing the State Merit List for conducting the Counselling for admission in different branches of B.E./B.Tech. Course of Engineering Institutes of Jharkhand State (List of Engineering Institutes for academic year-2025-26 is uploaded on the Board's website). The candidates must meet the following eligibility criteria:-

1. **Educational Criteria:-** The Candidate must have passed 10+2 examination with Physics/Mathematics / Chemistry / Computer Science / Electronics / Information Tech./ Biology/Informatics Practices/Biotechnology/Technical Vocational subject/Agriculture /Engineering Graphics/ Business Studies/Entrepreneurship as per table 8.4 & obtained at least 45% marks (40% marks in case of candidates belonging to reserved category) in the above subjects taken together OR Passed D.Voc. Stream in the same or allied sector. (As per AICTE Approval Process Handbook 2024-25 to 2026-27).
2. **Residential Criteria:-** The Candidate must be a citizen of India and Local/Permanent resident of Jharkhand. The "Local Resident of Jharkhand" has been defined & identified in 7/Aa. Niti (Sarvdaliaye Baithak) 27/2002 (Khand)ka.-3198/, dated 18.04.2016 of Personnel, Administrative Reforms and Rajbhasa Department, Govt. of Jharkhand.

Local Resident Certificate in proper format, issued by competent authority [Sub Divisional Officer– (Civil) or Dy. Commissioner of Jharkhand State] is required for candidates claiming admission.

- 3.(a) **Reservation on Caste Basis:-** The current reservation policy of Govt. of Jharkhand will be followed for admission in Institutes. Caste certificate in proper format, issued by competent authority [Sub Divisional Officer– (Civil) or Dy. Commissioner of Jharkhand State] is required for candidates claiming reservation.

Candidates belonging to BC – I & BC – II, will have to produce the caste certificate as per Letter no. 14/Ja.Ni.-03-13/2015/Ka.-1754 dated 25.02.2019 of Deptt. Of Personnel, Administrative Reforms and Rajbhasa, Govt. of Jharkhand.
Caste certificate produced by BC – I & BC – II Candidates will be valid only if he/she does not belong to creamy layer & it should be mentioned in caste certificate.

- (b) **Reservation for Economically Weaker Sections (EWS):-** Candidates from Economically Weaker Sections can avail benefits of reservation as per Memorandum (Memo No.-14/Aa.Ni.-04-02/2019/Ka.-1434 Dated 15-02-2019) of Personnel, Administrative Reforms and Rajbhasa Department, Ranchi.

Income & Assets Certificate in proper format, issued by competent authority [Sub Divisional Officer– (Civil) or Dy. Commissioner of Jharkhand State] is required for candidates claiming reservation.

- (c) **Reservation for Person with Disabilities:-** Divyang candidates can avail benefits of reservation as per Memorandum (Letter No. 2249 Dated 03.04.2018) of Personnel, Administrative Reforms and Rajbhasa Department, Ranchi.

Disability Certificate in proper format, issued by competent authority [Chairman of the Medical Board & Countersigned by Medical Superintendent/Chief Medical Officer/ Head of the Hospital of Jharkhand State] is required for candidates claiming reservation.

These certificates may be verified from Medical Board constituted at State level.

- (d) **Reservation for Service Man Quota (SMQ):-** :- Dependency Certificate issued by Competent Army Personnel for Serving Personnel/Dependency Certificate issued by Zila Sainik Kalyan Board for discharged Personnel/Discharge Book/Pension Book /Certificate as per their preference code is required for candidates claiming reservation.
- (e) **Reservation for Primitive Tribal Groups Candidates :-** Candidates from primitive tribal groups can avail benefits of reservation as per Memorandum (Letter No. 5555 Dated 28.06.2016) of Personnel, Administrative Reforms and Rajbhasa Department, Ranchi.
- (f) **Tuition Fee Waiver Scheme:-** As per AICTE, New Delhi, 5% Supernumerary seats are available for candidates in each branch. Income Certificate of upto Rs. 8 lakh, issued by Sub Divisional Officer– (Civil) or Dy. Commissioner of Jharkhand State is required for candidates claiming reservation.

The Notification/Memorandum copy and format of all the above certificates are available under "Act & circulars" and "Download" column on the Board's website.

4. **The Board will prepare the State Merit List on the basis of the JEE (Main)-2026 result and the claims made by the candidates in the online application form of JEE (Main)-2026 with respect to category and/or PwD status. Candidates who fill in a category in the State Merit List application form that differs from the category mentioned in the JEE (Main)-2026 application form will be considered under the unreserved category, except in cases where there is a difference between the Central and State caste lists. In such cases, candidates will be considered for the claimed category only after uploading the original caste certificate along with the application form. OBC candidates of JEE (Main)-2026 will be given the option to choose either BC-I or BC-II.**
5. **Rigorous verification of all Residential, Caste, Income, Disability Certificates etc. shall be done in detail in co-ordination with concerned district administration to identify any forged certificate or ineligible person getting certificate in wrong category, thus leading to criminal action & debarment from all exams & admission in any college across India.**
6. **Reserved category candidates recommended for admission under category seats will have to produce the original caste certificate, issued in the prescribed format by the competent authority, at the time of admission to the concerned allotted institute.**
